BARWON RIVER ENTRANCE LIGHT
BARWON RIVER CHANNEL MARKS

BE ALERT CHANGED CONDITIONS - WORKS IN PROGRESS

Date: With immediate effect.

Details: Mariners need to be alert to changes to aids to navigation in the Barwon River, Barwon Heads as works are being undertaken over the next week beginning 8th November, 2012.

Mariners are advised that the **outer port lead light** in the mouth of the Barwon River has limited visual range during this week of 1 NM, the lead light in position, $38^{\circ} 17' 12.68''$ South and $144^{\circ} 30' 13.72''$ East

Mariners are advised that three lit channel marker buoys have been placed in the river to identify the navigable channel as the existing 200mm diameter marker pins numbers 1, 2 and 8 north of the Barwon Heads Bridge in the river are in the process of being demolished.

The lit channel mark buoys are positioned;

Starboard lit buoy, $38^{\circ} 16' 39.46''$ South and $144^{\circ} 29' 50.97''$ East

Port lit buoy, $38^{\circ} 16' 33.54''$ South and $144^{\circ} 29' 58.29''$ East

Port lit buoy, $38^{\circ} 16' 11.98''$ South and $144^{\circ} 30' 28.26''$ East

Mariners are advised to exercise caution when navigating in the area.
