The following Victorian Notice to Mariners is published for general information.

Port of Hastings – 07th November 2016

Cruise Ship "Golden Princess" - Western Port

Victorian NTM 311 (T) 2016

Effective Saturday 19th November 2016.

Details: Mariners are advised of the visit of the cruise ship *Golden*

Princess within the local port of Western Port in the waters off Cowes, Phillip Island. Tender vessels will transport passengers to and from Cowes Pier between 1200hrs and 2300hrs on

Saturday the 19th of November.

An exclusion zone of 100 meters will be in place around the "Golden Princess". Mariners are directed to keep outside

this zone while she is in Western Port.

Mariners are also prohibited from entering the Parks Victoria mandated set aside area during the times nominated above and are advised to navigate with caution within the vicinity

of the cruise ship and tender activity.

Set Aside Determination - Regulation 11(1)

Local ports of Port Phillip, Western Port and/or Port Campbell

I, Graeme Davis District Manager of Parks Victoria (as delegate of the Port Manager), determine under Regulation 11(1) of the *Port Management* (Local Ports) *Regulations 2015* that the areas defined in the following table are set aside for the purposes and conditions specified.

This determination has been made in accordance with Regulation 11(2) (ii) significant interference with the safe, efficient and effective management of the local port.

In accordance with Regulation 11(4), this determination replaces any previous set aside determination made by the port manager in respect of that area or any part there of that area for the period specified in this temporary determination.

This determination applies from 19 November 2016 1200hrs until 19 November 2016 2300hrs.
