The following Notice to Mariners is published for general information.

Nepean Highway Bridge Construction - Exclusion Zone

Date: From Friday 23 March 2018 until 17:00hrs Friday 30 November 2018

Previous Notice(s): 090(T) – 2018 is referred.

Details: Mariners are advised that an exclusion zone has been declared for the purpose of bridge construction works at Patterson River at approximate location 38°04.359'S, 145°07.319'E (WGS84).

The exclusion zone is located between 60m upstream and 60m downstream of the Nepean Highway Bridge and has three work zone arrangements to facilitate a series of bridge span closures:

Work Zone One	Northern span river closure with vessel traffic restricted to the southern span transit channel.
Work Zone Two	Southern span river closure with vessel traffic restricted to the northern span transit channel.
Work Zone Three	Temporary full river closures for short durations to enable work zone transitions and for whole-of-bridge works.

The above work zone arrangements will be activated and marked by water communication buoys. Bridge spans will be open to one-way vessel traffic.

Mariners are prohibited from entering the marked exclusion work zones during the dates nominated above and are advised to navigate with caution within the vicinity of the Nepean Highway Bridge, Patterson River. Vessels travelling upstream have right-of-way.

Relevant Law: The exclusion zones have been established under section 211(1) (b) of the *Marine Safety Act 2010*. Navigation of vessels in the works area is prohibited, excluding vessels involved directly in the works and Parks Victoria vessels.

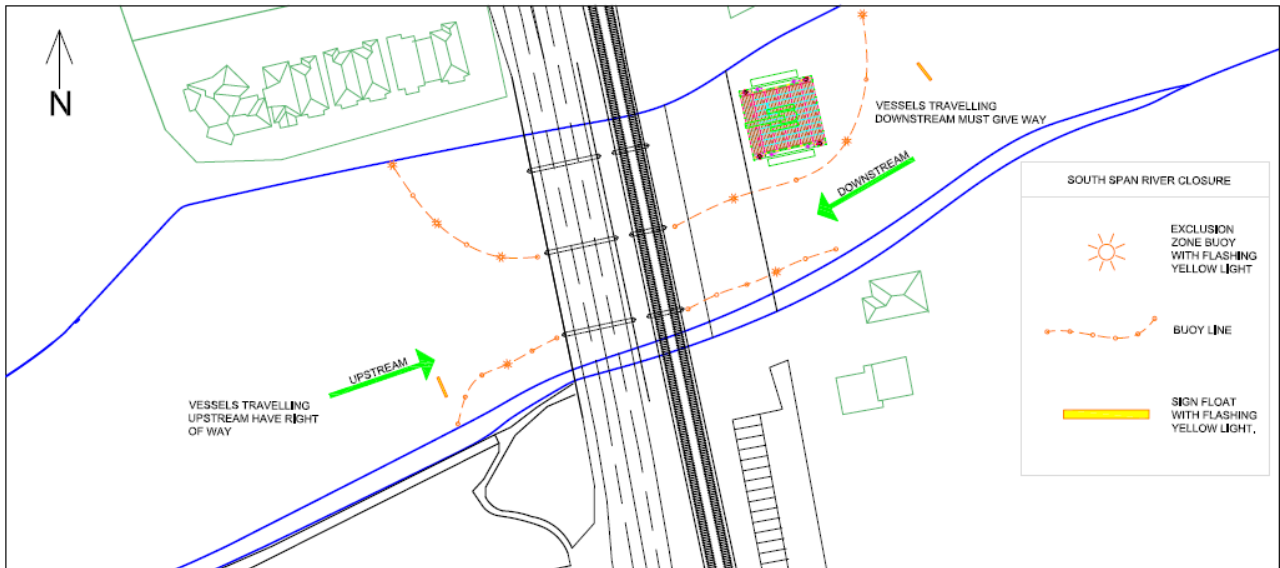

Northern span river closure with vessel traffic restricted to the southern span transit channel.

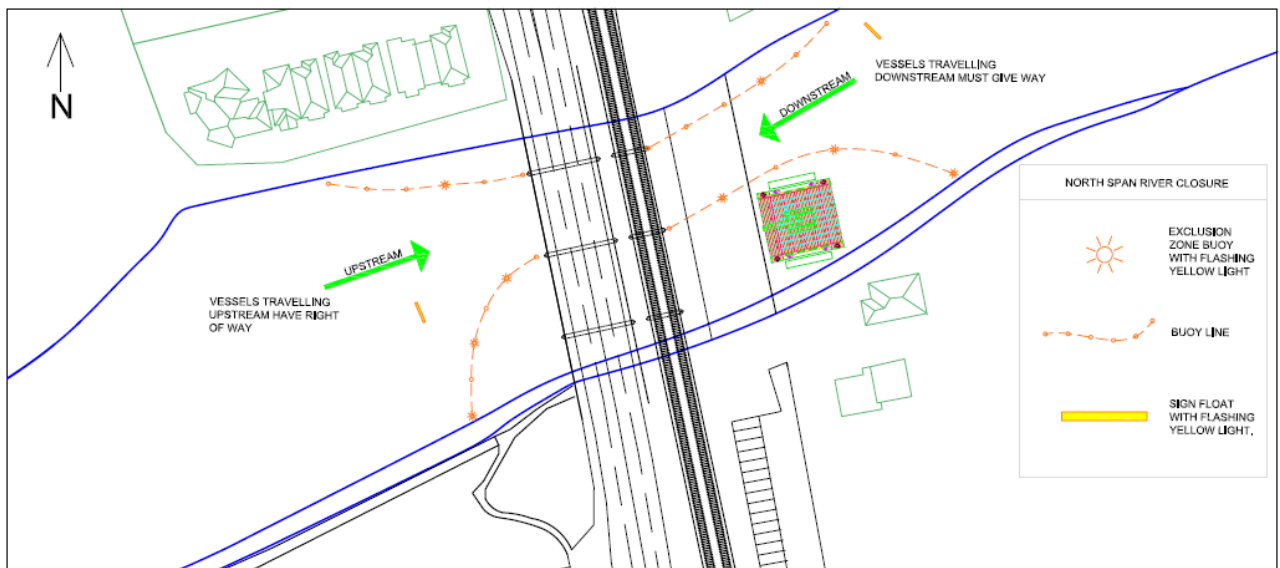
Note: Vessels travelling upstream have right-of-way
